If you moved from Maries County before January 1st you will not owe taxes in Maries County. Please return this list stating your new address and date moved.
Failure to return your Assessment List will result in a Penalty.
 Late Personal Property Lists - Sec. 137.280 of SB 62 requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the first day of March.
